Oxbow Donates Trees

Oxbow, Inc. has donated 1000 trees to the Hamilton County Free Tree Program. This program is part of a statewide initiative by the Ohio Department of Natural Resources' Division of Forestry to increase tree planting in Ohio by 5 million trees by 1995.

The Hamilton County Free Tree Program provides trees without cost to such organizations as churches, schools, and municipalities who agree to plant and care for the trees. Each of the trees will carry a tag identifying Oxbow, Inc. as the donor.

Low Level Dam Study

U.S. Fish and Wildlife Service employees from Bloomington, Indiana will visit the Oxbow area and investigate the feasibility of constructing a low level dam to help retain water in the Oxbow Lake. The dam can't be constructed if it would adversely affect land of other owners in the area, which is why the preliminary study is needed. USF&W will make a proposal to Oxbow, Inc. if they determine that the dam can be constructed and will improve the quality of the habitat in the area.

Goose Pond Restoration

The Goose Pond project is active again. A joint venture of Oxbow, Inc., The Hamilton County Park District, The Ohio Department of Natural Resources, and Duck Unlimited, the Goose Pond project will restore the silt-filled Goose Pond to a shallow water area suitable for shorebirds and ducks. Ducks Unlimited will provide the use of their bulldozer "The Blue Goose", and ODNR will provide the operator. The Hamilton County Park District is arranging for the permit, since the Goose Pond is on park land.

The restoration was postponed last summer because it was so rainy and wet that moving heavy equipment into the area was impossible.

Airpark News

An airpark, including a 2400 foot sod runway and portable aircraft hangers, is set to be built on property leased from I-275 Enterprises. The land is located behind Miller Cemetery.

The Oxbow Board of Trustees has hired attorney Tim Mara to look into the proposed Airpark. Mr. Mara is quoted in the Dearborn County Register as saying, "Oxbow questions whether the County Plan Commission and Board of Zoning acted properly in approving what they call a "special exception" to allow the airpark for small aircraft in the land zoned for manufacturing."

Mr. Mara will report on what he has learned to the Board at the April meeting.

Buffer Zone Expanded

The farm road that parallels the lake shore on Oxbow's land will be moved about 60 feet farther from the lake. The land in between will either be planted with trees or allowed to regenerate naturally, providing an additional buffer zone to isolate the lake from human activity and to reduce erosion of topsoil.

The expanded buffer zone was suggested by ecologist and Oxbow specialist Dr. Gae-Jae Joo, whose research on the wetlands in the area was supported by a grant from Oxbow, Inc.

Personnel from the Indiana Soil Conservation Service will visit the site to determine whether the buffer strip qualifies for support under the Conservation Reserve Program. This program could provide funds to help defray the cost of establishing the buffer strip.

Oxbow, Inc. plans to keep several strategically located foot paths open from the road to the lake shore. These paths should provide sufficient access for birding and other nature observation.

7-8 May (Friday-Saturday) 5 P.M. to 5 P.M. Oxbow Birdathon.


If you're not actually out counting birds, you can participate by pledging money to support the team of your choice. There's a pledge form in this Newsletter.

Fifties Root Beer

One of the most important landmarks in the Oxbow area is Fifties Root Beer. It's centrally located and easy to find on Route 50 just west of the Lawrenceburg exit off I-275.

For years, owner Tom von Holle has permitted Oxbow field trips to meet in the 50's parking lot. Sometimes people even have parked their cars there and carpooled with other field trip participants. Circumstances have recently made it necessary for Mr. von Holle to charge for parking in the 50's lot. Field Notes

What is so rare as a day in March? The week had been much as late winter should be, cloudy with some rain and a nice wet snow. The morning of our field trip into the Oxbow area broke bright and clear, with a heavy frost on the windshield, the trees, and the grass.

The Great Miami was running swift and muddy, the Whitewater had spilled out of its banks, and the Ohio was at 45 feet. The Oxbow was flooded. Jim and I had started about sun-up, and had checked the entire area before meeting the group. When we told the group what we'd found everyone was anxious to get started.

There was some ice around the edges of the big field by the Oxbow lake, but most of the water was open. Lots of the corn stalks had drifted into the tree line along Beaver Pond. The ducks and geese were busy searching for breakfast among the floating stalks.

First to catch our eye was a beautiful Tundra Swan. The large snow white bird had a black bill marked with yellow, just like in the field guide. Redheads were everywhere and the bright morning sun made it obvious why they'd received their name. Many other ducks shared the crowded tree line including Mallards, Blacks, Pintail, Gadwall, Wigeon, a few Ring-necked Ducks, Scaup, Goldeneye, Wood Duck, and one Ruddy Duck.

More than 100 Canada Geese worked the shallow water near a small island. Two blue-phase Snow Geese made a pretty picture standing on the ice. Jim checked the tree line around the Oxbow, finding more Wood Ducks, our first Shoveler of the season, and 7 Hooded Mergansers. Along the willows near Wood Duck Slough were several Green-winged Teal.

Our group moved on to see what was at Cemetery Lake. We turned up many more ducks, a Pied-Billed Grebe, several Great Blue Heron, and flocks of Ring-billed Gulls. Very noticeable were more than half a hundred mergansers — mostly Common and Red-breasted. With the fine weather and beautiful birds, it was a wonderful day for a trip to the Oxbow.

This year the late winter and early spring has been and is spectacular. To me it has been a real field of dreams. (If there is water, they will come.) I can't help but wonder how many thousands of birds have stopped to rest and feed at the Oxbow.
